# Introduction

This release note describes how to use the Broadband Access Center for Cable (BACC) Device Provisioning Engine 2115 (DPE-2115) Recovery CD-ROM to re-image a DPE-2115 device. It contains the complete instruction set you must follow to re-install the original software image supplied on the DPE-2115.



## Caution

The DPE-2115 recovery image can only be installed locally. You can not re-install the original software over a network.

## Using the DPE-2115 Recovery CD-ROM

This recovery CD-ROM contains one complete image of the software originally installed in the DPE-2115. If you need to re-image your DPE-2115, complete this procedure:



## Note

When re-imaging the DPE, all data stored in the DPE is lost. After being re-imaged, the DPE-2115 must be re-configured with the same configuration settings used on the previous DPE.

- Step 1** Insert the Broadband Access Center for Cable Device Provisioning Engine 2115 Recovery CD-ROM into the DPE-2115 and close the CD-ROM drive.
- Step 2** Power down the DPE by pressing, and holding the power button for at least 5 seconds.
- Step 3** Repeat the previous step to power on the DPE. This will boot the CD and prompt you to begin.
- Step 4** Enter this command when the *boot:* prompt appears:

```
install
```

The installation program begins to install the recovery image.

- Step 5** The re-image process completes in approximately 2 minutes and the recovery CD is ejected from the drive. Once ejected, the DPE is automatically rebooted.



## Note

During this reboot the screen displays an extensive array of technical data concerning the DPE and the programs running on it.

- Step 6** Once the reboot is complete, a verification procedure runs. At the end of this procedure, this prompt is displayed:  

```
Test Completed ok. Enter a <CR> to power off.
```
- Step 7** Press **Return** and wait for the system halted message to appear on screen. This indicates that the recovery process is complete.
- Step 8** Power cycle the DPE as described earlier in this procedure.

### Definitions of Service Request Severity

To ensure that all service requests are reported in a standard format, Cisco has established severity definitions.

Severity 1 (S1)—Your network is “down,” or there is a critical impact to your business operations. You and Cisco will commit all necessary resources around the clock to resolve the situation.

Severity 2 (S2)—Operation of an existing network is severely degraded, or significant aspects of your business operation are negatively affected by inadequate performance of Cisco products. You and Cisco will commit full-time resources during normal business hours to resolve the situation.

Severity 3 (S3)—Operational performance of your network is impaired, but most business operations remain functional. You and Cisco will commit resources during normal business hours to restore service to satisfactory levels.

Severity 4 (S4)—You require information or assistance with Cisco product capabilities, installation, or configuration. There is little or no effect on your business operations.
